This staff will perform field work, onsite monitoring and analysis, and field or laboratory analytical support. Supporting Lockheed Martin's team are Syracuse Research Corporation, Cherokee CRC, LLC, Dycon Government Solutions, Inc., and The ACI Group.

Lockheed Martin has supported the EPA's mission since 1974, providing evaluations of environmental conditions throughout the U.S. and ensuring that the agency's IT infrastructure is maintained, protected and capable of supporting its full range of environmental missions. Under this blanket purchase agreement, Lockheed Martin can provide IT and services across the EPA to enable secure information exchange, environmental data analysis, and scientific investigation.
