An indefinite delivery indefinite quantity contract, the DCPS agreement carries a 1-year base period with five 1-year options. It is valued at \$200 million if all options are exercised during the 6-year contract period.

Lockheed Martin will lead a team that includes Iron Data Solutions LLC, Atlanta, Ga., a company that supports 47 state IT disability case processing systems and known for its extensive knowledge of the disability domain. Global CI, Baltimore, Md., and MacQuarium Intelligent Communications, Atlanta, also are teammates, bringing expertise in Health IT and user-centered design practices.

The new system will provide cost savings to the SSA by eliminating the need to maintain separate systems for 54 state and federal sites. It also will help the agency process disability claims faster and with higher consistency.

The goal of the DCPS program is to help the SSA transform the processing of disability claims through a highly available, scalable and modern web-based system that will fully integrate with the central electronic disability process and recent advances in health information technologies. Creating a system that enables re-usable services enterprisewide, yet allows for site-specific customization of disability case processing is one of the program's key objectives. Simplifying systems maintenance and reducing the infrastructure costs are other key objectives.

The DCPS contract requires a case processing system solution that will manage approximately 4 million cases annually and be flexible enough to accommodate up to 50,000 staff. Key elements of the new system will include service-oriented architecture principles and methods, and the system also will incorporate services that will be available throughout the enterprise.

Headquartered in Bethesda, Md., Lockheed Martin is a global security company that employs about 133,000 people worldwide and is principally engaged in the research, design, development, manufacture, integration and sustainment of advanced technology systems, products and services.
