Littoral Combat Ship 17 (Indianapolis) Delivered To U.S. Navy

MARINETTE, Wis., July 26, 2019 - Lockheed Martin (NYSE: LMT) and Fincantieri Marinette Marine (FMM) delivered the future USS Indianapolis, Littoral Combat Ship (LCS) 17, to the U.S. Navy.

LCS 17 is equipped with several new features incorporated based on improved technology and operational feedback from more than 500,000 nautical miles under the keel of Freedom-variant LCSs. These capabilities include a TRS 4D solid-state radar, Navy Multiband Terminal (NMT), SeaRAM and topside optimization. LCS 17 and all future Freedom-variant ships will include these upgrades. Together, they provide increased situational awareness and commonality while integrating new technologies in support of evolving mission requirements.

"Speed to capability is an important focus for the Navy, and Lockheed Martin is committed to integrating and delivering innovative capability across all Littoral Combat Ships," said Joe DePietro, vice president of Small Combatants and Ship Systems at Lockheed Martin. "Today's security environment depends on providing sailors with advanced capability quickly, and these upgrades are one way we've modified our design to answer that need."

LCS 17 is the ninth Freedom-variant LCS designed, built and delivered by the Lockheed Martin-led industry team and will be commissioned Oct. 26 in Burns Harbor, Indiana. Indianapolis is the second Freedom-variant LCS delivered this year, after LCS 15 (Billings). Seven ships are in various stages of production and test at Fincantieri Marinette Marine.

"Today's important milestone was made possible by the investment and improvements made to our serial production line, which allowed us to realize our vision for a highly capable and efficient shipyard," said Jan Allman, Fincantieri Marinette Marine CEO. "Fincantieri Marinette Marine's shipbuilders are proud to deliver these proven warships, and we look forward to working with Lockheed Martin and the U.S. Navy to continue building these highly capable ships for the fleet."
